***NEW FORMAT FOR 2021  
Boater / Non-Boater Divisions***

Anglers who would like the opportunity to qualify for the 2022 National Semi-Final Tournament for Connecticut by fishing the 5 Tournament Trail events may do so by entering the “National Semi-Final – Trail Qualifier Division”. The 5 tournaments will take place between April 2021 and August 2021.

**National Semi-Final – Trail Qualifier Division**

Anglers who have paid an entry to fish in the “Boater” or “Non-Boater” divisions of the points trail may attempt to qualify for the National Semi-Finals by paying an additional, one-time fee of \$150 prior to the anglers first tournament. This fee is incremental to the individual tournament entry fees, regardless of what division is fished.

Anglers looking to qualify for the National Semi-Finals through the 2021 trail events will be ranked using their best 4 out of 5 tournament finishes throughout the course of the season. Points are accumulated over the year and the top finishers are guaranteed a spot at the National Semi-Finals.

**Boaters will compete against other Boaters. Non-Boaters will compete against other Non-Boaters.**

The positions are determined by the overall final points ranking, with the Top Anglers receiving one of 8 spots at the National Semi-Finals. The final number of spots from the Boater Division and the Non-Boater Division will depend on the number of registrants in each division and will be announced before the first event.
